

# Stepping Stones Luton Trustee Role Description (Legal Expert Trustee)

#### Introduction

As a trustee of the charity Stepping Stones Luton you hold legal responsibility for the strategic overview and administration of the organisation, and you are tasked with ensuring that Stepping Stones Luton pursues its stated objects (purposes) as set down in the governing document. Before you become a trustee you must ensure that you have read and understood said objects which can be located via the <a href="Charities Commission">Charities Commission</a> website. Stepping Stones Luton is a charity registered in England and Wales, charity number: 1162349.

### **Statutory Duties**

As the role of charity trustee is underpinned by the Charities Act 2011 (amended in 2022) the following are required of you within your role:

- Ensuring that Stepping Stones Luton complies with its governing document (for this
  please refer to our Amended Articles of Association)
- Ensure that all charitable resources are used and applied solely for the pursuance of the charitable objects of Stepping Stones Luton
- Uphold and safeguard the sound reputation and values of the charity at all times
- Ensuring that Stepping Stones Luton effectively and efficiently operates within its parameters
- Ensure that the relevant policies and procedures are in place and that these are reviewed annually by the trustee board
- Applying rigorous and purposeful financial checks to ensure the charity's funds and assets are used appropriately

In addition to these statutory duties each trustee is expected to use their experience, skills, and knowledge where appropriate to support sound decision making by the board. Where a trustee has particular expertise in an area they would be expected to lead informed discussion where said expertise can be utilised for the wider benefit of Stepping Stones Luton. Examples of this might include financial, legal, charitable governance, or public relations knowledge and experience.

### **Person Specification**

Being a trustee of a charity is both a privilege and a legal responsibility and the undertaking of trusteeship must not be considered lightly. Alongside the duties legally required of

trustees appointed by Stepping Stones Luton, all trustees are expected to demonstrate the following:

- Commitment and loyalty to the organisation. To promote the good works of the charity and its vision where appropriate
- Time and availability must be afforded to the role of trustee and correspondence pertaining to the charity's undertakings must be acknowledged responded to promptly
- Sound, independent judgment
- Ability to proactively challenge
- A clear understanding and acceptance of the legal responsibilities, duties and liabilities involved in trusteeship
- Ability to work as a wider, committed board
- Strategic and innovative thinker
- Understand the role and remit between the board of trustees, the CEO and wider staff team
- Emotionally robust and can act in the charity's best interested without fear

## **Legal Expert Trustee**

This trustee has the practical and theoretical knowledge of the law and advises the Chair and wider trustee board whilst also demonstrating the following:

- An understanding of the legal implications (actual and potential) of all aspects of the charity's strategic direction and operations
- Can provide relevant legal advice or secure trusted legal advice beyond own scope with regards employment, commercial properties (the leasing of), cyber security and fraud
- Leads on decisions and actions (actual and potential) where there could be legal consequences for the charity, to actively safeguard the charity's assets and reputation
- Proactively challenges decisions which they believe could render the charity legally liable
- Can access and co-opt individuals with legal expertise beyond own scope to advise on specific areas of charitable administration
